Further, I acknowledge that COVID-19 cases have been confirmed in Fond du Lac County, Wisconsin and surrounding counties. In accordance with guidance issued by the WHO, the United States Centers for Disease Control and Prevention (CDC), and the Wisconsin Department of Health Services (WDHS), for slowing the transmission of COVID-19, I hereby agree, represent, and warrant that the my child shall not enter District property and engage in the foregoing activities within 14 days after

- Returning from highly impacted areas subject to a CDC Level 3 Travel Health Notice
- Exposure to any person returning from areas subject to a CDC Level 3 Travel Health Notice

I agree that I am aware of the CDC Travel Health Notices list (<https://www.cdc.gov/coronavirus/2019-ncov/travelers/index.html>) and agree to check this list prior to signing this waiver.

MAKE SURE TO SCREEN YOUR CHILD PRIOR TO THEM COMING ON SCHOOL GROUNDS

I hereby agree, represent, and warrant my child will not enter District property and participate in the foregoing activities if he/she

- Experiences symptoms of COVID-19, including, without limitation:
 - Fever of 100.4 degrees or higher
 - Cough
 - Shortness of breath
 - Sore throat
- Has a suspect or diagnosed/confirmed case of COVID-19.
- Exposure to any person who has a suspected or confirmed case of COVID-19

DISTRICT PREPAREDNESS – INHERENT RISK

The School District of North Fond du Lac has taken reasonable steps to implement recommended guidance and protocols issued by Public Health Agencies for slowing the transmission of COVID-19, including, without limitation, the restrictions set forth above. I understand the inherent dangers for exposure to COVID-19 and other injuries while engaged in the foregoing activities on District property, which could result in quarantine requirements, serious illness, disability, and/or death and hereby assumes full responsibility for, and risk of,
